Lesotho Crisis (1998)

After Lesotho became independent in 1966, the Basotho National Party (BNP) established a one-party-system that lasted for almost three decades. After being beaten in elections in 1998, street protests against the new government were initialized; paving the way for a coup attempt by a faction of the national army. The conflict escalated when South African and Botswanan troops intervened in support of the elected government and although the revolt was effectively dampened by the end of the year, the political situation has remained fragile since.

Description	<p>A memorandum setting out an agreement reached about preparation to be taken for elections. It sets out the electoral-model to be used, and states that various groups and commissions will be created as follows: an expert group will be appointed to review the preparations for the elections and the timetable for elections, a new independent electoral commission appointed, a security liaison commission to take care of security, a contact group to meet with the prime minister, a joint committee on the media, joint implementation committee to facilitate implementation of the agreement and guarantors.</p>
