Each side will now convene to discuss their criteria before reconvening for bilateral talks by June 20. Regardless of the outcome of the talks, they will then meet again on July 15. The government guarantees the safe journey to the talks in Caracas. Both sides reiterate their wish to find a civilised solution to the armed political conflict.
