Description	A brief preamble for the subsequent agreements, all signed on the same date, of the implementations modalities for the Comprehensive Peace Agreement (CPA). The implementation modalities enclosed within the CPA Annexure II include the Implementation Modalities of the Protocol on Power Sharing and the Machakos Protocol, the Implementation Modalities of the Framework Agreement on Wealth Sharing, the Implementation Modalities of the Protocol on the Resolution of the Abyei Conflict, and The Implementation Modalities for the Protocol on the Resolution of Conflict in Southern Kordofan and Blue Nile States. Additionally, this preamble provides for the Permanent Ceasefire and Security Arrangements Implementation Modalities Agreement to also be included within the modalities to implement the CPA, as well as a List of Corrections for the protocols and agreements. Concluding, the Parties establish that the Constitutional Task Team shall have the responsibility of creating a mechanism for resolving any discrepancies during the implementation process.
