- Underline at the same time, the importance of the issuance of, and compliance with, the respective ceasefire orders; the effective use of disciplinary measures for ceasefire violations; no firing, including return fire; avoiding forward movements and reconnaissance missions; strictly forbidding, in particular, firing to and from populated areas, the presence and use of heavy weapons in and close to populated areas and the targeting of civilian infrastructure, including schools, kindergartens, hospitals, and public premises;
