Description This agreement is part of a series of dialogues between a touring presidential delegation and local armed groups in Ituri province, focusing on the Defence Forces Against Balkanisation of the Congo (FDBC) group specifically in the Djugu territory of Ituri. The agreement calls for an immediate end to hostilities among armed groups including attacks against Armed Forces of the Democratic Republic of the Congo (FARDC) and Police Nationale Congolaise (PNC). The provisions address a DDR programme as well as establishing a joint team to monitor ceasefire or 'truce'. The agreement also addresses the need for the armed group to support free movement of civilians and leave open humanitarian corridors.
