<b>Description</b>	The Ethiopian government and the Oromo Liberation Front (OLF) have reached a reconciliation agreement in Asmara. This accord, brokered with the involvement of Ethiopian officials, Eritrean President Isaias Afwerki, and OLF leader Dawud Ibsa, stipulates an end to hostilities and commits the OLF to peaceful political activities in Ethiopia. This development is notable given the OLF's historical resistance to Prime Minister Abiy Ahmed's peace overtures and the Oromo-majority's significant role in Ethiopian political reforms.
