Description	This document commits the signatories to cease military hostilities permanently and emphasizes the adoption of dialogue as the primary mechanism for conflict resolution, underpinning the mutual dedication to disarmament, demobilization, and the socio-economic reintegration of combatants. It outlines specific obligations for both parties to prevent acts of violence, ensure the smooth implementation of disarmament and reintegration processes, and introduces structured mechanisms for oversight and verification. Enacted within the broader context of Mozambique's pursuit of socio-economic development and national reconciliation, the agreement reflects a concerted effort to stabilize the nation through principles of democracy and human rights, while also detailing protocols for conflict resolution and safeguarding political figures and civilian populations.

1. DEFINITIVE CESSATION OF MILITARY HOSTILITIES

The Parties declare the definitive cessation of all military hostilities and commit themselves to ensure that all armed groups or institutions under their control scrupulously comply with all the provisions established herein. (📄 Locate in agreement)
