El Salvador Civil War (1979 - 1992)

The civil war in El Salvador lasted from 1979 to 1992 between an authoritarian government and non-state opponents. Following a failed coup d'état, five leftist guerrilla movements merged to form the umbrella organisation Farabundo Marti National Liberation Front (FMLN). U.S. support for the central Salvatorean government after 1979 lasted until its collapsed in late 1980s, after which the right-wing Republican National Alliance (Arena) filled the power vacuum. In March 1990, the rebels announced a suspension of attacks on non-military entered into talks backed by the UN and Catholic Church with the government. Despite the talks violence peaked over the next two years until the Chapultepec Peace Accords were signed in Mexico City in February 1992. Another ceasefire was signed a month later, which lasted nine months and was never broken during that time. Arena won the 1994 presidential elections and maintained a significant portion of the legislature until 2009, when the FMLN attained the presidency.

- (c) To visit any place or establishment freely and without prior notice;
- (d) To hold its meetings freely anywhere in the national territory;
- (e) To interview freely and privately any individual, group of individuals or members of bodies or institutions;
- (f) To collect by any means it deems appropriate such information as it considers relevant;

Page 5, II. INTERNATIONAL VERIFICATION

14. The Mission's mandate shall include the following powers:

- (g) To make recommendations to the Parties on the basis of any conclusions it has reached with respect to cases or situations it may have been called upon to consider;
- (h) To offer its support to the judicial authorities of El Salvador in order to help improve the judicial procedures for the protection of human rights and increase respect for the rules of due process of law;
- (i) To consult the Attorney-General of the Republic;
- (j) To plan and carry out an educational and informational campaign on human rights and on the functions of the Mission itself;
- (k) To use the media to the extent useful for the fulfillment of its mandate;
