c) After the provision of the logistical service support at Ri-Kwangba, the LRA shall within one month complete assembling of their forces.

d) Within two weeks of the assembly of the LRA within Owiny-Ki-Bul, the LRA shall provide all relevant information to the Mediator concerning of the LRA who may still be in Uganda.

e) The Mediator, the CHMT and the LRA shall ensure that the LRA forces remaining in Uganda relocate to Owiny-Ki-Bul within one month.
