Grievance List	<p>Page 1, For several years there has been such an entrenched disagreement between farmers and pastoralists in the commune of RUGOMBO, in the Province CIBITOKÉ, that in certain places the two parties do not even greet each other. Offences such as the slaughter of cows and the murder of shepherds have already been registered, highlighting difficult cohabitation between the two groups.</p> <p>After several exchanges with each other, the participants in the workshop have come to the conclusion that these attitudes derive from the following causes:</p> <ul style="list-style-type: none"><li>- the laxity of the cow herders;</li><li>- the plethora of herds;</li><li>- the shortage of pastures available for the grazing of cows;</li><li>- the notorious impunity benefiting herders responsible for damage;</li><li>- the nuisance attached to the attitudes of contempt shown by herders;</li><li>- the vagrancy of uncontrolled cattle;</li><li>- a galloping demography;</li><li>- a rapid expansion of herds in the areas of grazing;</li><li>- The free entry of cows across national borders;</li><li>- a great concentration of herds from the communes nearby and neighbouring countries;</li><li>- pathways obstructed for the passage of cows and transformed into fields.</li></ul>
Cattle rustling/ banditry	<p>Page 1, ... Offences such as the slaughter of cows and the murder of shepherds have already been registered, highlighting difficult cohabitation between the two groups.</p> <p>Page 2, 1. Commitments and claims of pastoralists, 1.2. Claims We, breeders, call on the farmers to do as follows:</p> <ul style="list-style-type: none"><li>- Not poison our cows, nor their inflict of injuries or beating;</li><li>- Not intimidate herders with the objective of scaring them away so that the cows left to themselves can wander in the fields and devastate large areas;</li><li>- Not to imprison cows, in particular those who have to breast-feed calves;</li><li>- Not criminalise cows when the latter have not been taken in the fields;</li><li>- Do not come rushing to lead the cows to the Municipality before having warned the owner and have shown to the elders.</li></ul> <p>Commitments and claims of farmers</p> <p>2.1. Commitments</p> <p>We, farmers, among farmers take the firm commitment below:</p> <ul style="list-style-type: none"><li>- Not to cause the death of cows, in any way whatsoever;</li></ul>
