Large group of participants, including government officials, met twice as part of this process. Another local peace agreement dealt with conflict in Gogrial State (see Gogrial Agreement between Twic, Aweil East, Aweil South and Gogrial West Counties of 13/07/2013), suggesting that this is not an isolated example.
