Description	Short unilateral ceasefire declaration in which Dan Nan Ambassagou, a non-state armed group led by Youssef Toloba, commits itself to immediately stop perpetrating violence. The group declares to sanction violations committed by its members, to oppose theft, and to raise awareness of the benefits of peace. It also calls on the Malian state and its partners to, among other things, provide humanitarian assistance, accelerate the DDR process, and support the families of conflict victims.

Rationale	This unilateral ceasefire was announced in the context of a 'seven-month mediation process undertaken by the Center for Humanitarian Dialogue, with the support of the regional authorities, on behalf of the Malian Government' (p.1). Limited contextual research does not suggest a track record of signing such agreements (Dan Nan Ambassagou was founded in 2016).

Link to national process: articulated rationale	The agreement was negotiated outside of the national-level peace process as it deals with conflict in central Mali. Dan Nan Ambassagou does not take part in the national-level peace negotiations at the time of writing.

Page 2, Chapter II: Strengthening the peace process between the Dogon and Peuhl communities, Section I: Commitment to a ceasefire and negotiations, Article 2: With a view to the effective implementation of the unilateral ceasefire, Youssouf TOLOSA and his armed group Dan Nan AMBASSAGOU commit themselves to:

...

• Oppose the theft / plundering of livestock regardless of its ownership;

Page 3, Chapter II: Strengthening the peace process between the Dogon and Peuhl communities, Section II: Access to pastoral resources (water points, passage of animals etc.), Article 4: Apart from the theft and looting of the cattle, the exclusion of certain users from access to water points is one of the major causes of conflicts in the area. Thus, Youssouf TOLOBA and his armed group Dan Nan AMBASSAGOU commit to no longer interfere with conflicts relating to accessing natural resources and to let the authorities manage these. He also states that revitalizing traditional spatial management mechanisms will be an important tool in the peaceful use of pastoral resources.
