Rationale The agreement concludes the second of three attempts to put an end to the dispute in Lerneb. This second attempt was initiated in Mauritania, presided by the Minister of the Interior and Decentralization, and undertaken in the presence of Ahmed Ould Bah, an adviser of the former President of Mauritania. It was also supported by the United Nations and the Government of Mali.
