**Description** A short local agreement of coexistence between two groups in the Murzuq region which substantively addresses return of displaced families and implementation of emergency development and infrastructure building for the two communities. The agreement also substantively addresses the need for confidence building activities in the shared city space and support for those with needs, including youth and women's initiatives.

## Local agreement properties

**Process type** Formal structured process

**Rationale** From the agreement text which describes designed confidence building measures and structured support from the Italian Ara Pacis Initiatives for Peace Organisation and the Italian government, as well as the Libyan government, the process is described as well supported. From further sources, there is also a clear recent history suggesting this agreement is part of a wider ongoing process between groups in the Murzuq district since 2018 and 2019 (see references for sources).

**Is there a documented link to a national peace process?** No

**Link to national process: articulated rationale** Although there are national supports to this local process, there is no clear reference in the agreement text or further source material to suggest this has a clear link to the national process.
