### Description

The local peace agreement in Sudan was signed on April 12, 2000, in Mulwal Agak area, between the Dinka (Abeyi, Tweig, and Gougrial) and the Messireya tribes. The agreement was supervised by Brigadier 8 Commander Simon Deng Sawein. The Dinka side agreed to recognize the Popular Movement and Sudanese Popular Liberation Army (SPLM/A) as the government fully responsible for the new Sudan, and demanded that nomads be strictly prohibited from carrying weapons in areas under the control of the SPLM. The agreement also specified the location of nomads, determined a location for trade activities, and required nomads to report to authorities before returning to their areas. Nomads were to pay a tax to the SPLM. On the other hand, the Messireya tribe requested protection of citizens and their properties, no shooting of their cows, and the cessation of cow theft. The peace committee agreed to all the conditions presented by the Messireya tribe.
