<b>Description</b>	The Sudanese Armed Forces and the Rapid Support Forces (RSF) agreed to a week-long ceasefire, an outcome resulting from Saudi and US-mediated negotiations. The conflict, which has led to significant societal breakdown, including food shortages and widespread looting, has been ongoing for over five weeks, causing massive displacement. Despite previous ceasefire agreements being consistently violated, this newly enacted seven-day ceasefire, set to commence on Monday evening, follows a declaration of principles established on May 12th.
