### The Follow-up of Security Arrangement in Aceh

To follow up the result of Geneva Agreement on Security Arrangement in Aceh, the Joint Committee on Security Matters facilitated by Henry Dunant Center again convened a meeting between RI and GAM field commanders from March 15 to 18, 2001. The meeting was also aimed at succeeding the performance of the truce in Aceh.

## III. Agreement

In the four-day meeting, the parties have agreed as follows:

- 1. For the purpose of security arrangement in Aceh, the two parties follow the guidelines of cessation of violence (dated February 10), both its material and applied mechanism.
- 2. For that purpose, full and consequent implementation of the cessation of violence, the two parties have decided a Peace Zone in North Aceh and Bireuen Districts as a pilot project of the cessation of violence for 13 days, starting from 00:00 AM on March 22 until 00:01 AM on April 3, 2001, under supervision from Monitoring Team for Security Matters facilitated by Henry Dunant Center, and it will be expanded regularly to other districts in Aceh based on the further evaluation.
- 3. The two parties agreed to function the role of the Court in Aceh as well as to guarantee the performance of its role free from any disturbance of all sides.
- Calling all parties to create a peace situation that set forward the dialogue as conflict resolution, as it has been agreed by the two parties in the meeting in Geneva.

5. The next meeting is convened on March 31, 2001.
