With the purpose of reaffirming the will for peace in the region of Bosnia and Herzegovina, the will for release of all persons and property from the pressure of armed conflicts and enemy activities, and the will for complete implementation of the Geneva Convention, dated 12 August 1949, as well as, the Protocol added to the Geneva Convention regarding the protection of victims of armed conflicts, negotiating sides agreed in the following:

- Release of all civilians, which are imprisoned. A representative of the negotiating team and a representative of the Spanish Battalion will be in charge of this activity.
- 2. Release of all civilians, which are, for security reasons, in shelters and facilities in the area of war activities. It is also necessary to submit lists containing the following data: first and last name, parents' name, date of birth, nationality, place of permanent residence, address of permanent residence, the date of registration at that address, the address to where the individual wants to move and the first and last name and the relation to the person whose place the individual is moving to. Lists of individuals who want to move from one local community to another will be prepared by Local Community Secretaries.
- Locations of the reception of the above-mentioned persons are "Đački Dom" and Department Store "Razvitak".
- ICRC /"International Red Cross Committee"/, whose presence is necessary in the locations of reception, will be informed about the reached agreement.
- Release of all imprisoned soldiers of the Army of BiH and HVO /"Croatian Defence Council", based on the "all for all" principle.
- Verification of all lists of persons will be carried out at the meeting of the negotiating team on 26 May 1993 at 1000 hours.
- Release of all civilians and soldiers will be carried out on 26 May 1993, at 1500 hours, in the location mentioned in Item 3 of this agreement.

- Aside from the list from Item 2 of this agreement, it is possible to make lists of requests for persons who can not report themselves, due to the war situation or for other reasons.
- Transport of persons mentioned in this agreement will be secured by the Army of BiH and HVO, followed by the Spanish Battalion.
